Subject: - Notice to declare Result for Skill Test held on 07.02.2026 and calling of E-dossiers for the Post of Computer Lab/IT Assistant under Post Code 96/23 in New Delhi Municipal Council.

1. The DSSSB vide its advertisement no. 03/23 with closing date 20/12/2023 had advertised 22 (Twenty-Two) vacancies (EWS-02, UR-11, OBC-05, SC-03, ST-01, Including PwBD-01, Including ExSM-02 & Including SP-01) for the Post of Computer Lab/IT Assistant in New Delhi Municipal Council under post code 96/23.
2. The written examination (online mode) for Tier-I (Technical) for recruitment in respect of this post was conducted on 27th July, 2024.
3. On qualifying online Written Examination, vide Notice No. 280 dated 09/06/2025, the DSSSB shortlisted 291 candidates for appearing in Skill Test for the post of Computer Lab/IT Assistant under Post Code 96/23. The Skill Test for said post code was conducted on 07th February, 2026, wherein out of 291 candidates, 233 candidates appeared for the skill test. In Skill Test conducted by DSSSB, only 182 candidates out of 233 candidates have qualified.
3. On evaluation of the Skill Test answer sheets of candidates, the candidates having speed of 8000 key depression per hour in English have been considered qualified as per Advertisement of said post code.
4. The roll numbers of 182 candidates who have qualified the Skill test for the Post Code-96/23, as per Advertisement, are as under: -

1. The candidates may please refer to the DSSSB advertisement no. 10/24 dated 30.12.2024 had advertised Total-07 vacancies [UR-03 (M-01,F-02), OBC-03 (M-03) & SC-01 (F-01)]for the Post of PGT Chemistry (Male/Female) under Post Code- 827/24 in Directorate of Education & New Delhi Municipal Council under combined exam scheme.
2. Vide said Advertisement, under Combined Examination Scheme; it has to be ensure that - **"The candidate must exercise at least one preference for a Post. Candidates, who don't submit their Post Preference within the stipulated time, will not be considered for any Post in the final result. Such candidates shall not be provided another opportunity to exercise preference for Posts".** Further, **"Final selection and allocation of department by DSSSB shall be based on merit cum preference only. The User Department shall check the eligibility as per RRs and other terms and conditions of the Advertisement Notice"**.
3. The marks obtained by **1032 candidates** who appeared in Tier-I written examination held on 17.04.2026 were uploaded on Board's website vide **Notice No.175 dated 11.06.2026**. Out of 1032, total 28 candidates were shortlisted to select their preference of Departments and upload the documents in e-dossier module - OARS from the period **17.06.2026 to 01.07.2026** subject to attaining minimum qualifying marks and correctness of the information furnished by the candidates in their online application form. The candidates were also directed to upload duly signed PREFERENCE FORM in e-dossier module. **Out of 28 candidates total 26 candidates have uploaded their documents in OARS module.** Total 02 candidates did not upload the e-dossier within stipulated time whose candidature has been rejected vide **Rejection Notice No. 194 dated 30.07.2026**.
4. As per the provisions of Notice No. **175** dated **11.06.2026**, allocations of the post to eligible candidates have been made on the basis of Merit-cum-Preference of posts submitted by the candidates in their PREFERENCE FORM uploaded in e-dossier OARS module.
5. As per the Board (DSSSB) resolution dated 14.7.2022, DSSSB shall neither undertake scrutiny of documents uploaded by the shortlisted candidates in their e-dossier nor check the eligibility of the candidates as per the Recruitment Rules for the post or the terms and conditions stipulated in the Vacancy Notice relating to age, experience, educational qualification, reserved category status, PwBD status etc. These will be checked by the

7. The provisional nomination of the above **Total-07 (UR-03 (Male-01, Female-02), OBC-03 (Male-03), SC-01 (Female-01))** candidates on the basis of claims in their applications shall be subject to thorough verification of their candidature by the User Department including the identity of the candidate as per services department Circular No. F.16(3)/2007/S-III/1756-1763 dated 02/08/2021.
8. The provisional nomination of the above **Total-07 (UR-03 (Male-01, Female-02), OBC-03 (Male-03), SC-01 (Female-01))** candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to fulfilled

all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement and subject to thorough verification of their identity with reference to their photographs, signature/ handwriting etc. on the application form, admission certificate etc. by the User Department. **The candidature of the candidate is liable to be cancelled by the User Department, in case, candidate does not fulfill any of the eligibility conditions of the Recruitment Rules for the post or for any genuine reason. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidate is fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Deptt., GNCTD after thorough verification of caste certificate.
10. User Department shall also get the SC/ST/OBC/EWS/PwBD/ExSM/Sports Person (with sub category) certificates verified from the issuing authority. Further, in case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DOPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2008 and 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017 and other instructions/ guidelines issued from time to time by the competent authorities.
11. In case of EWS candidates, it may also be verified that the validity of EWS certificate should be as per DOPT OM No. 36039/1/2019-ESTT(Res) dated 31.01.2019 and other instructions/ guidelines issued from time to time in this regard by the competent authorities.
12. The Competent Authority of the Department concerned shall issue the appointment letter to the candidate after verification of the correctness of the information furnished in the application form/e-dossier and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54 and other relevant instructions/ guidelines issued from time to time in this regard by the competent authorities.
13. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
14. The category wise marks secured by the last provisionally nominated candidate is as follows: -

The waiting panel is valid for a period of 01 (One) year from the date of declaration of main result for filling up the vacancies arising due to non-acceptance of the offer of appointment or not joining the post after acceptance of appointment or resignation after joining etc within one year of validity of panel.
17. As per Board's resolution dated 19th May 2021, in supersession of its earlier policy dated 13 June 2019 and in accordance with Services Department Circular No. F.16(3)/DSSSB/2007-S-III/1756-1763 dated 02/08/2021 the Board will also notify and nominate candidates to the extent of 20 % of notified vacancies. Out of the waiting/reserve panel comprising of all the candidates with above minimum qualifying marks as waitlisted candidates in order of merit and share it with the User Department with a request to utilize the same in conformity with DoPT guidelines and instructions of Govt. of NCT, Delhi issued from time to time and also mentioned in different clauses of this Result Notice. 19. As per the adv. No. 01/25 Para 5 (vii), If there are two or more candidates in the same category having equal marks in the examination:-
- Candidate securing more marks in subject specific section is to be placed higher in merit
 - In case where the marks mentioned at (a) above are also equal, the candidate senior in age is to be placed higher in merit.
 - In case where the date of birth(s) are also the same, the candidate whose first name comes first in Alphabetical order (in English) is to be placed higher in merit.
20. The User Department being Cadre Controlling/ Appointing Authority shall strictly follow the merit-based ranking of the candidate in the main list and the waiting list.
21. The User Department at its own level, will utilize the Waiting List, only after exhausting the main list and after affording sufficient opportunity to the provisionally nominated candidates as per the extant guidelines issued by the GNCTD/DoPT.
22. The candidates in the Waiting Panel or the Balance Reserve Panel shall have no claim or right for appointment per-se against the vacancies notified for the recruitment. They can only get the offer of appointment in the event any vacancy(ies) in their respective category arises due to non-acceptance of the offer of appointment or not joining the post after acceptance of appointment, etc. within one year of validity of panel.
23. While operating the waiting panel list, the User Department shall strictly follow instructions issued vide DoPT OM No. 36012/2/96-Estt. (Res) dated 02/07/1997, 36011/1/98- Estt (Res) dated 01/07/1998 and 430111/4/2018-Estt (Res) dated 04/03/2018 regarding shifting of candidates from respective reserve categories to the un-reserve category.
24. The User Department shall operate the waiting panel up to the number of vacancies notified under each category by the DSSSB in its advertisement and not beyond it even by taking any type of relaxation from any authority as it shall render the excess appointment void and illegal *Ab initio*.
25. As soon as validity period of the waiting panel expires and/or numbers of notified vacancies are filled up, the waiting panel becomes redundant and the User Department shall return the cancelled and unutilized dossiers to DSSSB with complete details/ statistics forthwith.
26. The case(s) of candidate(s) falling in main result or in proposed 20% waiting panel list where the Court has directed not to declare result without leave of the court, the same will be dealt separately. The User Department shall decide such cases subject to outcome of court case(s).
