The final result for appointment to the post of Library Assistant under Advertisement No. PHC/03/2022 for Library Assistant Recruitment Examination, 2022 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

- 1. Total 84 candidates who had attained the minimum qualifying standard in the computer based written test comprising Multiple Choice Question based Objective Test as prescribed in the clause 7 (i) of the Advertisement No. PHC/03/2022 were called for appearing in the Computer Proficiency Test.
- 2. The candidates who have attained the minimum qualifying standard in the Computer Proficiency Test as prescribed in the clause 7 (ii) of the Advertisement No. PHC/03/2022 have been considered for preparation of final result. The marks obtained by a candidate in the Computer Based Written Test alongwith marks obtained in the Computer Proficiency Test have been taken into consideration.
- 3. Candidates securing marks equal and above the marks secured by the last candidate selected in Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
- 4. If two or more candidates have secured equal marks, the candidate securing higher marks in the written test has been placed above and if the marks obtained in the written test are also equal, then the candidate born earlier has been placed above.
- 5. The result has been prepared after following the 100 point roster-reservation policy adopted in the establishment of Court at the time of advertisement. The names of candidates are in order of merit and their category of selection is indicated against their names at <u>Annexure-I</u>.
- 6. The prepared result comprises 08 candidates under UR Category including 03 female candidates, 02 candidates of EWS Category, 02 candidates under BC Category including 01 female candidate, 04 candidates under EBC Category including 01 female candidate and 01 OH candidate, 03 candidates under SC Category including 02 female candidates & 01 candidate under ST Category.

Out of total 20 candidates, 01 candidate of OH Category has been horizontally placed in his respective category.
