TRANSLATOR AND TRANSLATOR-CUM-PROOF READER (FOR SUVAS CELL) RECRUITMENT EXAMINATION, 2024

NOTICE

The final result for appointment to the posts of Translator and Translator-cum-Proof Reader under Advertisement No.-PHC/01/2024 for Translator and Translator-cum-Proof Reader (for SUVAS Cell) Recruitment Examination, 2024 is being published alongwith this notice for information to all concerned. The candidates must take notice of following facts which have been taken into consideration for preparation of final result:

1. Total 133 candidates who had attained the minimum qualifying standard in the Computer Proficiency Test as prescribed in the Advertisement No. PHC/01/2024 were called for appearing at the Interview. Out of them, 131 candidates appeared, while 2 did not turn up for the Interview.
2. The candidates who have also attained the minimum qualifying standard in the Interview as prescribed in the Scheme of Examination have been considered for preparation of final result.
3. The marks obtained by a candidate in the Written Test and Interview along with Test of Translation in Maithili/Urdu/Santhalī have been taken into consideration for preparation of final result.
4. Candidates securing marks equal and above the cut-off marks of Unreserved Category have been placed in the Unreserved Category while other candidates have been placed in their respective category of reservation.
5. Any candidate who has availed the relaxation of age by virtue of their caste/category has been considered in their respective caste/category.
6. No candidate has qualified under OH quota, hence, 03 seats of UR Category have been kept vacant in view of clarification communicated by the State Government vide letter no.496/J. dated 18.01.2023.

7. Only one candidate bearing Roll No.102814 had claimed SC category in his/her online application on the basis of Tanti (Tatwa) caste, however, in light of the Judgment dated 15.07.2024 passed by Hon'ble Supreme Court of India in Civil Appeal No. 1880212017 titled Dr. Bhim Rao Ambedkar Vichar Manch Bihar Vs. State of Bihar, the Tanti (Tantwa) caste has been restored at Sl. No. 33 in the list of EBC, i.e., Extremely Backward Class (Schedule-I) category in the Bihar Gazette published by the General Administration Deptt., Govt. of Bihar under its letter dated 12.08.2024. This candidate initially qualified as an SC category candidate in the Written Test and Computer Proficiency Test, but, at the time of interview he/she produced the 'Non-Creamy Layer' Certificate for availing benefit of reservation of EBC category as notified vide this Court's Notice. The candidature of this candidate was again assessed as per cut-off of EBC candidate at each stage of the examination and upon finding him/her qualified as per EBC criteria, his/her result has been declared in EBC category.
8. If two or more candidates have secured equal marks, the candidate securing higher marks in the written test has been placed above and if the marks obtained in the written test are also equal, then the candidate born earlier has been placed above, however, preference has been given to a candidate possessing law degree over other candidate in the matter of selection only, if they have secured equal marks.
9. Candidates have been allotted post as per their 1st preference. Second preference given by the candidate was taken into consideration only when, all the seats of his/ her first preference were exhausted.
10. Wherever required, the deficit of female candidates, as per requisite vacancy, has been met by replacing male candidates:
- ❖ 5 male candidates in UR Category and 1 male candidate in BC Category have been replaced by female candidates of respective category.
11. The names of candidates are in order of merit in the result and their category of selection and post for which they have been selected is indicated against their respective names at **Annexure-I**.
12. The result comprises 68 candidates details of which are:

15. Candidates selected under any of the reserved categories will have to produce certificates as mentioned in clause 5 of the advertisement issued by the competent authority, failing which their joining shall not be accepted.
16. Candidates will have to produce all the relevant documents regarding their educational qualification in support of their claim to ascertain their eligibility as on 01.01.2024 for the post of Translator and Translator-cum-Proof Reader for SUVAS Cell in terms of relevant Rules as well as the advertisement No. PHC/01/2024. If a candidate fails to produce the required documents within the time as stipulated in the Appointment Letter his/ her joining shall not be accepted and their candidature may also be cancelled.
